2025 HELSINKI, FINLAND SOLO ICE DANCE OPEN

The 2025 Helsinki Solo Ice Dance Open will be conducted in accordance with the Finnish Solo Ice Dance Competition Guidelines 2024/25 General Rules and Requirements and the International Solo Ice Dance Competition Guidelines 2024/25 Technical Rules and Level Requirements. Skaters must provide a passport or other proof of age to verify they meet the age requirements as outlined in the International Solo Ice Dance Competition Guidelines.

Competition Venue

The Competition will take place at Herttoniemi Ice Rink, Helsinki, Finland. The ice surface is 28 meters by 58 meters with rounded corners. The rink is heated.

Event Requirements

The requirements for International Solo Ice Dance Competitions will follow the requirements announced annually in the ISU International Solo Ice Dance Guidelines:

- General Rules and Requirements
- Technical Rules and Requirements
- Scale of Values

Events offered will be:

Beginner
 2 Pattern Dances and 1 Free Dance

The Pattern Dances will be skated prior to the Free Dance.

Age Requirements (met before July 1st preceding the competition):

• Beginner – has not reached the age of ten

Technical Requirements

Beginner:

- Dutch Waltz
- Canasta Tango
- Free Dance (1"30 +/- 10 sec)

Competition Registration

Entries must be submitted to the OC by ISU Members via the electronic Entry Form no later than Thursday March 6th, 2025 to the following email: hsidi.contact@gmail.com. Confirmation of entries will be sent no later than Friday 7th of March 2025. Please do not make any travel arrangements until you receive the confirmation of entries.

Entry Fee

The entry fee for all events will be 100€. The entry fee will be invoiced and sent via e-mail to the clubs after confirmation. The invoice must be paid at latest on the due date: Monday 17th of March 2025. In case of non-payment, the OC reserves the right to consider the pertinent entries withdrawn. In case a skater(s) has been entered in the competition, but cannot participate, they can be replaced by another skater(s) in the same category and class until the draw. Participating clubs are asked to inform immediately of any changes in their entries by emailing hsidi.contact@gmail.com. The entry fee will only be refunded in cases when the withdrawal of the skater(s) occurs seven (7) days before the closing date: Friday 14th of March 2025, or upon presentation of an official certificate stating a medical reason preventing the participation.

Entries submitted after the Closing Date, Monday March 17th, will be subjected to the late entry fee of 125€ and will be treated in order of appearance and subject to the remaining available spots.

Panel of Judges

Each participating ISU Member may nominate one international judge or ISU judge educated in the ISU judging system. The organizer decides on the composition of the panel of judges. In case of too many nominated judges, the organizer reserves the right to reduce the number of judges. The Members concerned will then be notified of the result. The OC will cover the board and lodging for accepted judges and invited officials as of the dinner on the day before the start of their activity until the end of their activity, or for the day when the official is on duty.

The OC will provide and cover the expenses for travel (based on economy fare), rooms and meals in accordance with Finland's general travel policy for the invited Referees, Technical Controllers, Technical Specialists and Data Operators. Should any Official arrive at the hotel before or stay longer than the period afore mentioned, the expenses will be their own responsibility and must be paid upon arrival.

The OC will not cover any expenses for Competitors, Team Leaders, Coaches, or Chaperones.

Accommodation

All Teams must cover their accommodation expenses by themselves.

Accreditation

The official accreditation point will at Herttoniemi Ice Rink on Friday April 11th from 4.30pm.

Accreditations will be given to all Competitors, Coaches, Officials, Team Leaders and other Team Members. An official identity document must be presented at the accreditation for verification.

Accreditation will be made only for skaters whose entry fees have been paid. It is not possible to pay the entry fee on site.

Opening Draw

The Draw will take place electronically on Monday April 7th and will be published online. The Starting Order for Free Dances will be the reverse of the Pattern Dances and Rhythm Dances results.

Music

The participating ISU Members and their Clubs are responsible for submitting their skaters' music(s) as a direct attachment to an email to the OC (hsidi.contact@gmail.com) by March 17th, 2024.

Please note: some music files might exceed the size of a regular email. In this case, an email-based transfer service which allows to send large files could be used to send the file to the OC. Each Skater must have their own back-up drive (USB stick) for each program in the format of a WAV or an MP3 file.

The exact running time of the music (not skating time) must be communicated to the OC when submitting the music and shall be certified by the Competitor/Coach/Team Leader at the time of registration.

Presentation of Medals

The first three best placed Competitors in each event will be announced and honored after the event.

The OC assumes no responsibility nor liability with regards to bodily or personal injury nor is the OC liable for any property damage incurred by Competitors or Officials. The OC will provide Medical Emergency Aid during the Competition.

Transportation

The nearest airport to Helsinki is Vantaa Airport (HEL), with a distance of 45 mins approx. to the city center.

Transfer from the airport to the Helsinki main railway station is frequent and easy. Local train lines "I" and "P" take 45mins door to door.
